Narr/(U) Change to Read. This is a SECDEF-approved EXORD Modification (MOD) that directs the Department of Defense (DoD) to immediately stop movement for international travel to prevent the

spread of Coronavirus Disease 2019 (COVID-19) and to protect and preserve the operational effectiveness of forces worldwide.

Gentext/Situation/

- 1. (U) Situation.
- 1.A. (U) Rapidly changing global conditions have created significant risk to forces, as DoD continues movements and travel overseas. This continued movement increases the likelihood of spreading COVID-19 to other Service Members and civilians.
- 1.B (U) This MOD temporarily supersedes conflicting portions of the Secretary of Defense (SecDef) Travel Restrictions for DoD Components in Response to Coronavirus 2019, dated March 11, 2020 (REF B) for the 60-day duration of the stop-move order.

3. (U) Execution.

3.A. (U) Tasks.

3.A.1. (U) DoD Components.

- 3.A.1.A. (U) Stop-movement of all international travel for DoD uniformed and civilian personnel and their sponsored family members not under the responsibility of a U.S. Chief of Mission for a period of 60-days, effective 24 hours from publication of this EXORD MOD.
- 3.A.1.A.1. (U) Stop-movement includes all forms of official travel and movements associated with Permanent Change of Station, Temporary Duty and government-funded leave, and all Global Force Management

(GFM) activities. It also includes service member personal leave.

- 3.A.1.B. (U) Exceptions.
- 3.A.1.B.1. (U) Travel by patients and medical providers for the purposes of medical treatment for DoD personnel and their families is authorized.
- 3.A.1.B.2. (U) Scheduled deployments/redeployments of U.S. Navy vessels and embarked units and personnel is authorized, provided they are in transit for 14 days and have met the restriction of movement

(ROM) requirements associated with current force health protection guidance (REF D).

- 3.A.1.B.3. (U) Individuals who have already initiated travel (including intermediate stops) are authorized to continue to their final destination.
- 3.A.1.B.4. (U) Individuals whose TDY ends while this order is in effect are authorized to return to their home station.
- 3.A.1.B.5. (U) U.S. Transportation Command (USTRANSCOM) is authorized to continue execution of the Joint Deployment and Distribution Enterprise as required to project and sustain the Joint Force globally. This includes forces (aircrews, vessel crews, and mission essential personnel) ordered by the Secretary on prepare to deploy orders (PTDO) alert status, air refueling, Global Patient Movement, Mortuary Affairs support, inland surface, sea and air sustainment missions, support to other U.S. Agencies as approved by SecDef, and moves of personnel and equipment that support USTRANSCOM global posture requirements.

- 3.A.1.B.6. (U) Additional exceptions to this order may be granted in writing in cases where the travel is: (1) determined to be mission-essential; (2) necessary for humanitarian reasons; or (3) warranted due to extreme hardship.
- 3.A.1.B.6.A. (U) Approval authority for exceptions for Global Force Management activities is the Joint Staff Director of Operations (DJ-3). Submit all exceptions to policy to the Joint Staff DJ-3 via the Joint Staff COVID-19 CMT.
- 3.A.1.B.6.B. (U) Approval authority for all other exceptions belongs to the Combatant Commander if the individual is assigned or allocated to a Combatant Command; the Chairman of the Joint Chiefs of Staff if the individual is assigned to the Joint Staff; the Secretary of the Military Department concerned for personnel under his/her jurisdiction; or the Chief Management Officer for the Office of the Secretary of Defense, Defense Field Activities and Agencies.
- 3.A.1.B.6.C. (U) Exceptions are to be done on a case by case basis, shall be limited in number, and shall be coordinated between the gaining and losing organizations, as appropriate.
- 3.A.1.C. (U) Authorized travelers will adhere to the Force Health Protection guidelines (REF D) and later guidance, if any.
- 3.A.2. (U) Joint Staff.
- 3.A.2.A. (U) Provide SecDef a conditions-assessment prior to expiration of this 60-day stop-movement order. Condition considerations will include:
- 3.A.2.B. (U) Force Providers, Combatant Commands, and USTRANSCOM ability to meet restriction of movement (ROM) requirements.
- 3.A.2.C. (U) Host Nation policy considerations regarding DOD force deployments.
- 3.A.3.D. (U) COVID-19-related infrastructure at forward deployed locations.

- 4.A. (U) USTRANSCOM requests CCMDs send a NEWSGROUP with all ULNs that are affected. Additional guidance as required will be issued per USTRANSCOM order.
